 - Need for restructure of Prioritization
 - Prioritization: Risk Factors (disabilities, open child welfare cases, physical health, substance abuse, mental health), Age of Youngest Child (under 1, under 5), previous homelessness, Length of Time Homeless

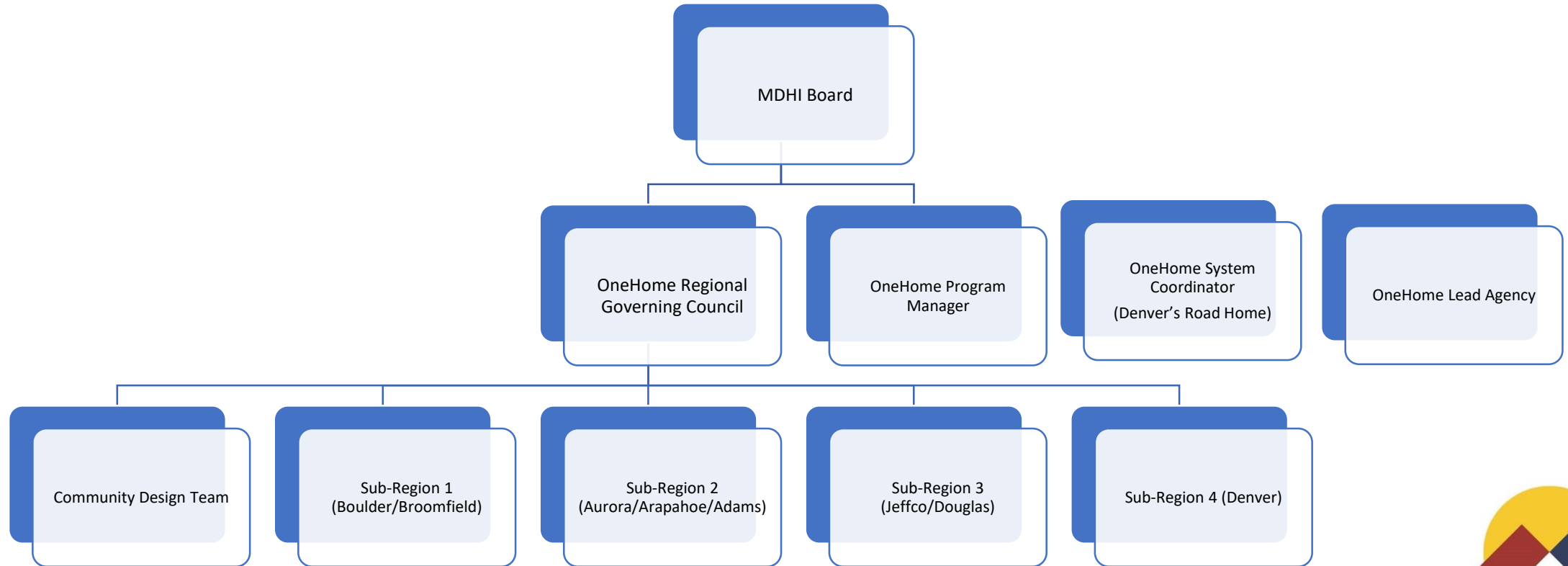

Lead Agency Role Description

- A Coordinator and Housing Navigator per Agency hired by March
 - VOA-CO will co-facilitate Youth meetings
 - CCH will co-facilitate Family meetings
 - VOA-CO and CCH will lead one Alternate Process and Case Conferencing
 - VOA-CO and CCH will co-facilitate CDT
 - VOA-CO and CCH will attend RGC
- Revise OneHome policies and procedures to reflect Youth and Family additions, and Individual updates
- Coordinate Housing Navigation (HN) for clients in Pre-Match, working directly with clients as needed to fill the gaps. Maintain regular documentation on pre-match & quarterly review of clients
- Work with Housing Providers and match eligible clients to housing resources expediently
- Provide light touch case management to 10 households monthly
- Develop a warm handoff protocol between housing navigation and housing provider
